Private Party Release and Waiver of Liability Agreement

For Sun Lakes Country Club Homeowners Association

I hereby acknowledge that the Sun Lakes Country Club Homeowners Association ("Association") permits association members to use certain recreation and dining facilities as exclusive use facilities for private parties when such facilities are not in use by the general membership. I further acknowledge that, as the host of a private party, I am solely responsible for making all arrangements associated with my party and that any involvement on the part of the Association is provided strictly as an accommodation.

I further acknowledge that, as a resident of an age restricted community, I am more susceptible to accidents and recreation related injuries than a younger person, and I agree to assume the risks of physical injury, or loss or damage to my property, that may result from activities either directly or indirectly related to my use of the Association's recreation or dining facilities for my private party. I further acknowledge that as a condition of my use of the Association's recreation or dining facilities I agree to hold harmless all of the persons and entities as and to the extent mentioned below.

THEREFORE, IN RECOGNITION OF THE FORGOING, I HEREBY RELEASE, DISCHARGE AND HOLD HARMLESSFROM LIABILITY AND WAIVE ANY CLAIM I MAY HAVE AGAINST THE SUN LAKES COUNTRY CLUB HOMEOWNERS ASSOCIATION. ITS OFFICERS, DIRECTORS, EMPLOYEES, AGENTS AND VOLUNTEERS (COLLECTIVELY "SUN LAKES") FOR ANY INJURY TO ME OR MY GUEST, OR LOSS OF OR DAMAGE TO MY AND OR MY GUESTS PROPERTY AS A RESULT OF MY USE OF SUN LAKES' RECREATION OR DINING FACILITIES FOR MY PRIVATE PARTY, EXCEPTING LOSS OR DAMAGE CAUSED BY THE GROSS NEGLIGENCE OR INTENTIONAL MISCONDUCT OF SUN LAKES.

6.07 PRIVATE PARTY ROOM USE POLICY

8. All private parties where minor children (under age 18) will be attending will require additional community patrol support. One (1) community patrol personnel will be scheduled to work at the party site for each group of eight (8) or more minors in attendance.
